

Miss Kentucky

COLLEGE/UNIVERSITY TITLE HOLDERS

Young ladies who hold college titles may apply to compete in the Miss Kentucky Competition.

The following guidelines must be established:

- A candidate meets all eligibility requirements of the Miss Kentucky Competition and understands that she must compete in all phases of competition at the state level.
- A candidate must have won her competition through a judging process.
- Certification from the college certifying that the candidate won the title at a judged college event and she has permission to use the university or college title in the state competition.
- The College/University appoints an advisor to work with the candidate from the time of her selection through the state competition.
- The College/University pays the same license fee as a local organization (\$500).
- Winner raises \$100 for Children's Miracle Network Hospitals (CMNH) (just as an official local contestant does). This is done online via the Miss America CMNH website. All **local titleholders** must raise an additional \$250 for CMNH to compete at the state competition.
- Winner receives a scholarship from the school she is representing.
- Winner is required to sign the standard Miss America Local/State Candidate Contract.
- College Titles may include but not be limited to Homecoming Queen, Most Beautiful, etc. State Board will make the final determination.

KENTUCKY STATE FAIR AND FESTIVAL TITLEHOLDERS

Young ladies who hold Fair and Festival Titles may apply to compete in the Miss Kentucky Competition.

- A candidate must be able to meet all eligibility requirements of the Miss Kentucky Competition Local/State contract and must understand that she must compete in all phases of competition at the state level.
- A candidate must have won her title through a judging process.
- Verification is required certifying that she won the title and that she is under no obligation regarding appearances or activities that would interfere with her obligations should she become Miss Kentucky. She may not wear a sash, crown, or any symbol of these other types of titles once she is representing her local or state title (example: if she is asked to crown her festival/fair/etc. successor, she will do so as Miss Local or Miss Kentucky, not as the out-going festival, etc.).
- Fair/Festivals must be a one-time event where the representative does not go on to compete for another title within the Fair/Festival program.
- An advisor is appointed to work with the candidate from the time of her selection through the state competition.
- A license fee is paid (\$500).
- Winner raises \$100 for Children's Miracle Network Hospitals (CMNH) (just as an official local candidate does). This is done online via the Miss America CMNH website. All **local titleholders** must raise an additional \$250 for CMNH to compete at the state competition.
- Winner is required to sign the standard Miss America Local/State Candidate Contract.
- Titles may include but not be limited to a local fair or festival queen, talent show winner, dance competition winner, homecoming queen, etc. The Miss Kentucky State Board will make the final determination.

TEEN FAIRS/FESTIVALS/HOMECOMING AND OTHER TITLES

Teens who holds a Fair and Festival Titles or who have participated in a judged event may apply to compete at the Miss Kentucky's Outstanding Teen Competition.

The following guidelines must be established:

- A candidate must be able to meet all eligibility requirements of the Miss Kentucky's Outstanding Teen State/Local Contract and must understand that she must compete in all phases of competition at the state level.
- A candidate must have won her title through a judging process.
- Verification is required certifying that she won the title and that she is under no obligation regarding appearances or activities that would interfere with her obligations should she become Miss Kentucky's Outstanding Teen or Miss America's Outstanding Teen. She may not wear a sash, crown or any symbol of these other types of titles once she is representing her local, state, or national MAOTeen title (example: if she is asked to crown her festival/fair/etc. successor, she will do so as Miss Local, State, or National Outstanding Teen, not as the out-going festival, etc.)
- Fair/Festivals must be a one-time event where the representative does not go on to compete for another title within the Fair/Festival program.
- An advisor is appointed to work with the contestant from the time of her selection through the state competition.
- A license fee of \$300 is paid.
- All local titleholders must raise \$250 for Children's Miracle Network Hospitals (CMNH) to compete at the state competition. This is done online via the Miss America's Outstanding Teen CMNH website.
- Winner is required to sign the standard MAOTeen Local/State CandidateContract.
- Titles may include but not be limited to a local fair or festival queen, talent show winner, dance competition winner, homecoming queen, etc. State Board will make the final determination.
